Treasurer Report

The collection of promissory notes has been moving along. In the 2003 fiscal year (October – September), \$10,474 was collected from promissory note payments. The first of two yearly mailings to remind people to pay their promissory notes went out in January with the typical interest charges being assessed. Interest charges can be avoided by simply setting up a payment plan and making regular payments. If you did not receive this mailing and have not paid your promissory note, please contact me so that we can work to take care of this responsibility.

In an effort to establish fundraising income, K.S.R. Ltd. became a Pick ‘N Save We Care charity. With this program, alumni shopping at Pick ‘N Save grocery stores in Wisconsin can have a percentage (about 1%) of their total bill be donated to the organization of their choice. The sign-up process is simple. Visit the customer service counter at your local Pick ‘N Save and sign up for an Advantage Plus card, or ask for a change form if you already have an Advantage Plus card. On the form, there is a spot to put the number of your charity; the number for K.S.R. Ltd. is 400100. You can put up to three charities on your Advantage Plus card and the money will be split evenly between those charities. The new fundraiser for this year will probably be working concession stands at Milwaukee area sporting events, so do not be surprised to get a phone call requesting some help working the stand.

With the above projects underway, a few new things will be receiving my attention in the coming year. The first is establishing a yearly local alumni dues program similar to program recently started by the national organization. The main difference between the programs will be that the great majority of the local alumni dues will not go into our general account, but instead be used for a specific purpose to be determined each year. You will find the first of such local alumni dues payment forms in this Aggregate. In the spirit of our newly announced Plan 2004 (see Kevin Robertson’s article), this year’s special project for alumni dues will be the bar and permanent audio system in the basement of the chapter house. A number of alumni and actives have already started work on rebuilding the bar in the basement and adding a beautiful back bar area including a sink, custom stained glass, and shelves to hold house mugs. As for the audio system portion, Jason

Moulden marq95 has graciously offered his services and contacts in the professional automation services business to create a professional audio solution with the ability to play different audio in the various rooms (game room, dining area, chapter room, etc.).

Another one of my intentions this year is improving communication with the entire alumni base about K.S.R. Ltd.’s financial activities. To this end, I have recently posted K.S.R. Ltd.’s expenditures for the last few years on our website, <http://marq.triangle.org/KSR>. Any comments about these expenditures are welcome including suggestions on how to reduce expenditures in certain areas. Related to this, I am also interested in suggestions on where to direct future funds. As we approach the establishment of stable financial reserves, K.S.R. Ltd. has started to look for ways to use and invest our income from promissory notes. House improvements and establishment of a house building/improvement fund is one popular idea among board members, but I am always looking for new ideas. My contact information is in this Aggregate in case you want to respond to any of my above requests for comments or suggestions.

Finally, I wanted to list the alumni who have paid off their promissory notes since the last Aggregate (May 2003) and who are currently on payment plans. On behalf of KSR and the rest of the alumni, we thank you for supporting the chapter.
